**Between**

**Merchants' Chamber of Commerce & Industry** established under The Companies Act, 1913 as amended from time to time and having its registered office at 15B, Hemanta Basu Sarani, Kolkata 700001, India. Hereinafter sometimes referred to as MCCI which term or expression shall mean and include the said Merchants' Chamber of Commerce & Industry its successors and assigns, on FIRST PART.

**And**

**The Bhawanipur Education Society College**, 5, Lala Lajpat Rai Sarani, Bhawanipur, Kolkata, West Bengal 700020 (herein after referred to as BESC), an undergraduate college affiliated with the University of Calcutta in Kolkata, West Bengal, India on SECOND PART.

Wherein Merchants' Chamber of Commerce & Industry & BESC shall hereinafter jointly referred to as the Parties.

**And whereas:**

- I. The Parties have appreciated each other's objectives in promoting excellence inter alia in common area of interest, imparting knowledge and skills required to operate in the area of education focusing on trade, commerce & industry and are desirous of entering into an agreement for mutual benefit and advantage.
- II. The Parties are also desirous of working together for identifying other areas of mutual co-operation between them.
- III. The Parties hereto are desirous of putting the broad terms of the intentions into a Memorandum of Understanding for the areas identified for co-operation and commit to fully co-operate by mutual understanding.
- IV. This MOU is subject to the approval of the respective Governing Councils of the parties hereto and subject to changes as may be desired.
- V. Both the Parties have hereto identified the following areas where they agree to mutually cooperate to the fullest extent:
  - a. Hold joint workshops, seminars, continuing education, and programmes for students on themes of trade, commerce & industry.
  - b. The chamber will assist the college in organizing factory visits to suggest and recommend resource persons for various topics of academic interest jointly organized including both educational and research initiatives.
  - c. Assist in organizing entrepreneurship and startup workshops along with other such initiatives that will be beneficial to the students.
  - d. Regularly exchange course materials, case studies, research publications and other academic and research inputs.
  - e. Provide the college assistance in placement and internships.




- VI. The MOU is being entered for an initial period of One (1) year from the date of signing unless the same is renewed for a further period as may be mutually agreed by the parties.
- VII. This MOU may be terminated by mutual consent of the parties. Either party may also terminate this MOU upon (3) months written notice to the other.
- VIII. This MOU will be governed by and constructed in accordance with the law in force in India and shall have Kolkata jurisdiction in respect of all matters arising under the terms in this MOU. This MOU may only be amended by agreement in writing between the parties and not otherwise.
- IX. Usage of Logo of the either party shall be restricted to the extent of operation/premise of this MOU only.
- X. Any dispute arising out of the operation of this MOU shall be resolved through mutual dialogue.
- XI. Nothing in this MOU will have any financial bearing on either party.
