Sub : Grant of Permission for introduction of Post-graduate Course in English

Sir,

In connection with the letter No.Aff(CU)/MS(67)/SCHE/2015 dt.11.03.15 of W.B.State Council of Higher Education addressed to the Vice Chancellor, C.U. for introduction of Post-graduate Course of Study in English in Bwanipur Education Society College the undersigned is hereby directed to inform you that the matter was placed before the Hon'ble Vice-Chancellor when he had pleased to order for placing the matter before the Syndicate. The report of the Inspection Team constituted by the Vice-Chancellor, C.U. for granting permission for Introduction of P.G. Studies in English from the academic session 2015-16, on self-financing basis in Bwanipur Education Society College be accepted and approved by the Syndicate dt.22.09.15 (Item No.35) and confirmed by the Syndicate dt.07.10.15 (Item No.1) subject to fulfillment of the following conditions.

1. Intake capacity for the course must not exceed 50 (fifty).
2. Course fee is to be fixed at not more than Rs.32,500/- per student per year in total.



3. The College should initially follow the syllabus as well as the present system of examination as introduced by the University of Calcutta for 2 years and should also frame the rules and regulations regarding admission and pass marks in accordance with the rules and regulations followed by the University of Calcutta. However, after two years the college is required to frame its own syllabus, rules and regulations independent of the pattern followed by the University of Calcutta.
4. The college should update and augment the library in connection with introduction of Post-graduate studies in English.
5. The college must appoint two whole-time contractual teachers as per UGC norms and 5 (five) number of guest teachers for the said course.
6. The teachers should be appointed through a duly constituted selection committee having the representative/expert nominated by the University.
7. The college is also required to engage one supporting non-teaching employee for the proposed course.

Sub: Introduction of M.Com course of studies at Bhawanipur Education Society College, Kolkata

Sir,

In cancellation of the earlier letter no. 2240/UCAC/CU dated 29-09-10 the undersigned as directed by the Vice-Chancellor, University of Calcutta, vide his order dated 10-11-10 informs you that the Syndicate in its resolution dated 27-09-10 vide agenda no. 1c (confirmed by the Syndicate on 09/11/10) has resolved that the Bhawanipur Education Society College be granted provisional permission for three years to introduce semester-based M.Com course of studies on a self-financing basis, with an annual intake of 70 (seventy) students to be admitted strictly on the basis of merit from the academic session 2010-11 subject to the following conditions:

- 1) The college must follow the University notification no. CSR/9/05 dated 07-03-05 as also all other statutory provisions of the Calcutta University First Statutes, 1979 as existing, proposed or as may be amended from time to time.
- 2) The amount of Tuition and other fees payable annually by students shall in no case exceed Rs.20,000/-.
- 3) That at least 5% and 10% respectively of the permitted intake shall be reserved for admission of students under full-free and half-free quota in each year.
- 4) Specialisation: 50% of the intake capacity should have Accountancy and Finance as specialisation and balance 50% should have Marketing.
- 5) At least two whole-time teachers be appointed exclusively for the M.Com course of study and requisite number of part-time guest faculties may also be appointed.
- 6) Teachers should be selected by a duly constituted selection committee as per University rules and regulations.

7) The Board of Studies for the M.Com course of studies be constituted at the earliest as per the University rules/regulations.

8) Teachers should be provided with minimum infrastructure and other facilities for the purpose of conducting research activities.
