MEMORANDUM OF UNDERSTANDING (MoU)

(FOR THE DEVELOPMENT OF ACADEMIC COOPERATION IN HIGHER EDUCATION)

BETWEEN

THE BHAWANIPUR EDUCATION SOCIETY COLLEGE

KOLKATA –700020, INDIA

AND

HOWRAH-711315, INDIA

This Memorandum of Understanding ("MoU") is to promote academic linkages between the two institutions and facilitate their development of collaborative and mutual programs that will enhance the intellectual life of both institutions, contribute to increased cooperation and promote mutual understanding. Thus, Ulubria College, Uluberia, Howrah -711315, West Bengal, and the Bhawanipur Education Society College, West Bengal, Kolkata –700020, have agreed to the following:

1. Framework for specific Agreement

This Memorandum of Understanding ("MOU") is a framework for specific collaborative initiatives to be developed between the two institutions.

2. Area of Collaboration

Both parties have agreed to explore and implement mutually regarding initiatives in the following area of academic cooperation:

- Online and offline sharing of innovative ideas in Teaching-Learning
- e-Governance
- · Collaborative research
- Sharing of scientific information on area of mutual interest
- Faculty and student mobility
- Library sharing
- Joint national/ international seminars/ workshops
- Other academic collaboration, including publications.

3. Development of initiatives

Area of cooperation will be defined between the Uluberia College, Howrah and The Bhawanipur Education Society College, Kolkata throughout the duration of the MOU and further agreement of academic agreements of academic collaboration may result for specific collaborative activities.

Neither institution shall have any financial commitments to each other, nor through this MOU, real or implied. Bothe parties agree, however, to endeavor to secure government, corporate or other party funding where possible in order to support the collaborative activities covered by the agreement.

4. Confidentiality and Intellectual property rights (IPR) protection

Both the institutions shall respect and retain confidentially in each/ any of the collaborative efforts and all collaborative academic exercises shall be guided, directed and impelled by the greater academic interest of both the colleges and not any other/ commercial interest.

This MOU will respect Intellectual Property Rights and any intellectual matter developed by the collaborative efforts of two institutions shall be retained by them.

5. Duration, Amendment and Termination of the MOU

This MOU will remain in effect for a period of 5 (five) years from the last date of signing. It may be amended at any time by mutual agreement and in writing as an addendum. No legal relationship between the two institutions is implied through this agreement. Either party may terminate for this MOU at any time and for any reason by giving the other party at least three (3) months written notice of its decision.
