MEMORANDUM OF UNDERSTANDING

ACADEMIC COOPERATION IN HIGHER EDUCATION

This Memorandum of Understanding ("MOU") is to promote academic linkages between the two institutions and facilitate their development of collaborative and mutual programmes that will enhance the intellectual life of both institutions, contribute to increased cooperation and promote mutual understanding. Thus Paschimbanga Itihas Samsad, Kolkata-700020, West Bengal and The Department of Bengali & History, The Bhawanipur Education Society College, 5 Lala Lajpat Sarani, Kolkata- 700020, West Bengal have agreed to the followings :

1. Framework for specific Agreement

This Memorandum of Understanding ("MOU") is a framework for specific collaborative initiatives to be developed between the two institutions .

2. Areas of Collaboration

Both parties have agreed to explore and implement mutually rewarding initiatives in the following areas of academic cooperation :

2.1 Organizing seminars, workshop, symposium at The Bhawanipur Education Society College in association with Paschimbanga Itihas Samsad.

2.2 Encouraging historical awareness among students and arranging internship program according to University (Calcutta University) norms.

2.3 Other academic collaborations, including publications.

3. Development of Initiatives

Areas of cooperation will be defined between the Paschimbanga Itihas Samsad and The Bhawanipur Education Society College throughout the duration of the MOU and further agreement of academic agreements of academic collaboration may result in specific collaborative activities.

Neither institution shall have any financial commitments to each other, through this MOU, real or implied. Both parties agree, however, to endeavour to secure government, corporate or other party funding wherever possible in order to support the collaborative activities covered by the agreement.

4. Confidentiality and Intellectual property rights (IPR) protection

Both the institutions shall respect and retain confidentiality in each/ any of the collaborative efforts, and all collaborative academic exercises shall be guided, directed and impelled by the greater academic interest of both the colleges, and not any other commercial interest. This MOU will respect Intellectual Property Rights and any intellectual matter developed by the collaborative efforts of two institutions shall be retained by them.

5. Duration, Amendment and Termination of the MOU

This MOU will remain in effect for a period of 6 (six) years from the last date of signing. It may be amended at any time by mutual agreement and in writing as an addendum. No legal relationship between the two institutions is implied through this agreement. Either party may terminate this MOU at any time and for any reason by giving the other party at least 3 (three) months' written notice of its decision.
